FIRST ORDER OF BUSINESS

Call to Order

Mr. Roethke called the meeting to order and called the roll.

SECOND ORDER OF BUSINESS

Audience Comments on Agenda Items

Mr. Roethke stated for the record that there were no members of the general audience present.

THIRD ORDER OF BUSINESS

Consideration of the Minutes of the Board of Supervisors' Meeting held on April 16, 2015

There were no changes to the meeting minutes.

On a motion by Ms. Valenti, seconded by Mr. Piendel, with all in favor, the Board of Supervisors approved the minutes of the Board of Supervisors' meeting held on April 16, 2015 as presented for Long Lake Ranch Community Development District.

FOURTH ORDER OF BUSINESS

Consideration of the Operation and Maintenance Expenditures for March 2015

Discussion ensued regarding several invoices. Mr. Santoro mentioned that a \$300.00 invoice from Cornerstone for a stormwater inspection should be billed back to Long Lake Ranch, LLC. Mr. Roethke stated that he would take card of this item.

On a motion by Ms. Valenti, seconded by Mr. Beeman, with all in favor, the Board of Supervisors approved the Operation and Maintenance Expenditures for March 2015 (\$60,290.58) as presented for Long Lake Ranch Community Development District.

FIFTH ORDER OF BUSINESS

Ratification of Series 2014 Construction Requisitions #64 - 68

Mr. Roethke presented the Series 2014 Construction Requisitions #64 - 68. There were no questions.

On a motion by Mr. Beeman, seconded by Mr. Santoro, with all in favor, the Board of Supervisors ratified the Series 2014 Construction Requisitions #64 - 68 as presented for Long Lake Ranch Community Development District.

SIXTH ORDER OF BUSINESS

Consideration of Florida Natives Nursery's Proposal

Mr. Roethke presented a proposal from Florida Natives Nursery for plant installation.

On a motion by Ms. Valenti, seconded by Mr. Santoro, with all in favor, the Board of Supervisors approved the aquatic installation proposal from Florida Natives Nursery at a cost of \$34,324.00 to be paid from the construction fund for Long Lake Ranch Community Development District.

SEVENTH ORDER OF BUSINESS

Discussion Regarding Designation of Fishing and Boating Areas

Mr. Rogers provided a map of the community and a discussion ensued regarding where to allow fishing and boating within the community. Mr. Rogers will adjust the map to include these designated fishing/boating areas that the Board discussed.

EIGHTH ORDER OF BUSINESS

Discussion Regarding Landscape Maintenance

Ms. Valenti discussed some areas of landscaping that are ready to be turned over to the District and mentioned that many of the areas do not look satisfactory. There will be a walkthrough onsite with the vendor on May 28th to discuss any landscape issues before the areas are turned over to the District. A proposal will be presented at the next meeting for the District to contract for landscape and irrigation maintenance services.

NINTH ORDER OF BUSINESS

Discussion Regarding District Signage

Ms. Valenti mentioned that the District will need to order new signage for the pool, fishing, and parking. She asked for a motion to approve a not-to-exceed amount to purchase additional signs.

On a motion by Mr. Beeman, seconded by Mr. Santoro, with all in favor, the Board of Supervisors approved a not-to-exceed amount of \$6,000.00 for the Chairman to purchase signage on behalf of the District for Long Lake Ranch Community Development District.

TENTH ORDER OF BUSINESS

Discussion Regarding Amenity Services

Mr. Roethke presented two proposals for Amenity Management Services. He stated that the first was an addendum to the Landscape Maintenance Inspection Services Agreement, which will provide monthly field operations oversight.

On a motion by Ms. Valenti, seconded by Mr. Beeman, with all in favor, the Board of Supervisors approved the proposal from Rizzetta Amenity Services for monthly field operations management at a cost of \$6,000.00 per year (monthly \$500.00 commitment) for Long Lake Ranch Community Development District.

Mr. Roethke stated that the second proposal was for seasonal club attendants to work onsite.

On a motion by Ms. Valenti, seconded by Mr. Beeman, with all in favor, the Board of Supervisors approved the proposal form Rizzetta Amenity Services for seasonal club attendants at a total not-to-exceed cost of \$11,521.00 for the remainder of this Fiscal Year (July 1st through September 30th) pending further review of the contract by District Counsel for Long Lake Ranch Community Development District.

Mr. Roethke and Ms. Suit reviewed a draft of the Fiscal Year 2015/2016 proposed budget with the Board. Mr. Roethke stated that he would work with Mr. Santoro on the proposed budget and it would be presented at the next meeting.
